1. Başvuru Koşulları - Application Conditions

- Applications will be made through the **Online Application Form**.
- Applications made with missing documents will not be evaluated.
- Candidates who are determined to apply with incomplete or false statements and documents or who do not submit the original documents submitted during registration are not registered; If done, their registrations are canceled regardless of the period they are in.
- Application with Outside Institutional Success Average in Spring Term is only for Associate Degree programs.
- Students who wish to transfer to programs whose medium of instruction is English must meet the conditions accepted by the University. Students who do not have a national or international exam certificate showing English language proficiency must take the Foreign Language Exam at Nişantaşı University.

2. General Conditions

The minimum requirements to be met in the applications for transfer (Inter-Institutional Lateral Transfer) to Nişantaşı University diploma programs are as follows:

- **Registration Status:** The student must still be a registered student in an associate / undergraduate diploma program of any higher education institution. Suspending enrollment is not an obstacle to applying for transfer. Students with unregistered status cannot apply for transfer.
- **Study Period:** The student must have studied at least two semesters in the undergraduate degree program, excluding preparatory school and summer school, until the beginning of the semester in which he / she wants to transfer. Students cannot transfer to the English Preparatory Program, the first two semesters and the last two semesters in undergraduate diploma programs. The student must have studied at least one semester in the associate degree program, excluding preparatory school and summer school. Students cannot transfer to the English Preparatory Program, the first two semesters and the last one semester in associate degree programs.
- **General Grade Point Average (GPA):** At least 60 out of 100 in the program in which the student is registered (minimum 2.29 out of 4.00); For applications from evening education or distance education, your GPA must be at least 80 out of 100 (at least 3.15 out of 4.00). Those who cannot meet the specified success requirement but whose ÖSYM center placement score of the year they are enrolled is equal to or higher than the base score of the diploma program of Nişantaşı University that they want to transfer to, can apply for transfer. If the Nişantaşı University undergraduate diploma program has not been established in the relevant year, the student's transfer application cannot be evaluated for the relevant program.
- **Percentile in Evening Education Programs:** In applications from evening education diploma programs to formal education programs, the student must also be in the first ten percent of the class he / she is in and move to the next class.

3. Additional Application Conditions According to the Programs

In addition to the above-mentioned application requirements, students must also meet the following additional application requirements for the relevant programs:

- For the Architecture program: Students who have registered and enrolled in the University as of the 2016-2017 academic year are also required to be in the lowest 200,000th rank in the transfer applications. . As of the 2018-2019 academic year, students enrolled in the University are required to be in the lowest 250,000th rank in the transfer applications.
- For engineering programs: In the transfer applications of students who have registered to the University as of the 2016-2017 academic year, the success condition is also required to be in the lowest 240,000th rank. As of the 2018-2019 academic year, students enrolled in the University are required to be in the lowest 300,000th rank in the transfer applications.
- English Language Proficiency:

When applying to programs whose medium of instruction is English, English language proficiency must be provided. Students who cannot achieve their language proficiency are not enrolled, and if they are, the registration is deleted. Candidates must certify that they have achieved sufficient success in the exams named below, which are accepted by the authorized units of Nişantaşı University.

4. Documents Required for Application

Application documents must be prepared in Turkish or English. In other languages, certified translations in Turkish or English must be submitted in addition to the originals.

- Application Form: Online Application Form filled in correctly and completely.
- Student Certificate: A signed and sealed document prepared by the university that the student is registered. In the document, it should be stated that the student's class, the language of instruction of the program, the type of admission (ÖSYM placement, transfer, etc.) and that she/he is still registered

- Document Indicating the Disciplinary Situation: A signed and sealed document showing the disciplinary punishment status of the student, prepared by the university that the student is registered. (It is also accepted if it is specified on the student certificate.)
- Transcript: A transcript prepared by the university that the student is registered, showing all courses taken, grades and grade point averages. If the transcript does not contain explanatory information about the grading system and the language of instruction of the program, the documents containing this information should be attached to the transcript.
- Course Description and Content Information: Documents containing detailed descriptions and content information of the courses specified in the transcript.
- ÖSYS / DGS (Including Placement Scores and Success Ranking) Result Document:

The document showing all YGS / LYS placement points and rankings and placement results, which will be obtained from the ÖSYM website, belonging to the year in which the student is registered to the university where he / she is registered. For students placed with DGS, a document showing all placement scores and rankings of DGS and the result of the placement.

- ID Card Copy: Two-sided copy of ID card. A copy of the blue cards of the blue card holders.
- High School Diploma: A certified copy of the diploma allocated by the high school of graduation.
- For English programs: Certified copy of the national or international English Language Proficiency Certificate, if available

5. Documents Required for Registration

- Original copies with wet signature of the documents used in the application and a certified photocopy of the high school diploma if the original is not available.
- Passport Photo (2 Pieces)

6. Conditions for Adjusting Courses

The adjustment of the courses taken and successful in the previous diploma program of the undergraduate transfer students is determined according to the principles of Nişantaşı University Exemption and Adjustment Directive. The grades of the courses assigned are written on the transcript.
